

WATER SERVICE INTERRUPTION

OKANAGAN FALLS

This is to advise that the Water Service in your area will be intermittently shut off between 8:00 am to 5:00 pm on the date(s) below:

Dates: August 12 - August 16, 2024

Time: 8:00 am to 5:00 pm daily

LOCATION:

Properties along Maple St south of 10th Ave to Ferguson Pl.

In preparation for the water service shut down, please ensure that you have an adequate supply of water on hand for domestic use.

Once service is restored, you may notice adverse water quality (high colour, suspended solids, and turbidity). If you experience dirty water, simply run your cold water taps only and/or garden hose until the water runs clear. Residents may also wish to isolate their in-home treatment systems until turbidity has decreased to normal levels. In addition, residents are advised to refrain from laundering for a period of at least one day.

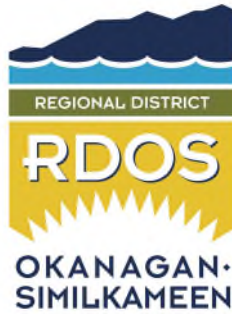

Drivers in Okanagan Falls can expect on-and-off closures on Maple St from the morning of Monday, August 12 to the end of day Friday, August 16, 2024.

This notice is to alert drivers of the intermittent road closures in order to facilitate new and upgraded utility services in the area.

The closure will affect Maple St between the bridge south of 10th Ave and Weyerhauser Rd. Local traffic only will be redirected by traffic control persons to the appropriate entrance to Maple St depending on their destination.

RDOS staff are asking that people drive safely and consider alternate routes during the closure.

WATER QUALITY ADVISORY

OKANAGAN FALLS WATER SYSTEM USERS

August 8, 2024

The Regional District of Okanagan Similkameen will issue a **Water Quality Advisory** on Monday, August 12 at 8:00 am for all residents affected by this shut-down notice as there is the potential for a change in water quality. This **Water Quality Advisory** will remain in effect for the duration of the works and remain in effect until further notice.

What is a Water Quality Advisory?

A **Water Quality Advisory** is a level of notification below a Boil Water Notice and is used in situations where the general public health threat is modest.

Who may need additional protection during a Water Quality Advisory?

- People with weakened immune systems
- Infants and children
- The elderly
- People with chronic illnesses
- People wishing to seek additional protection

Precautionary instructions

Those individuals seeking additional protection are advised to use a safe alternate source of water or to boil water for all drinking, infant formula preparation, brushing teeth, food preparation/cooking purposes, and ice making. Water should be brought to a full boil and allowed to boil for at least 1 minute.

It is advised that a safe alternate source of water be used for preparing formula for infants due to the potential for elevated manganese levels during this time.

The RDOS would also like to remind all business owners/operators and public facilities operators that it is the responsibility of said establishments to notify their customers of the **Water Quality Advisory**.
