BYLAW NO. 1513

A Bylaw to amend the Electoral Area 'D' Land Use Contract No. LU-9-D Bylaw No. 206, 1974

The REGIONAL BOARD of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. TITLE

This Bylaw may be cited for all purposes as the "Electoral Area 'D' Land Use Contract No. LU-9-D Bylaw No. 206, 1974, AMENDMENT BYLAW NO. 1513, 1994".

2. That in accordance with Section 947 (2) of the Municipal Act the Bylaw has been examined in conjunction with the current capital expenditure program, and the applicable waste management plan of the Regional District of Okanagan-Similkameen.
3. That Land Use Contract No. LU-9-D Bylaw No. 206, 1974 be amended by adding subsection (d) to Part 5 "Siting" to include the following:
- d) i) On Lot 6, Plan 38989, District Lot 2169, Section 36, Township 89, S.D.Y.D. (previously the westerly portion of Lot 19) from 1 dwelling unit to 3 dwelling units; and
 - ii) to permit the subdivision of the said property into three (3) parcels, as shown on attached Schedule 'X' which forms part of this Bylaw.



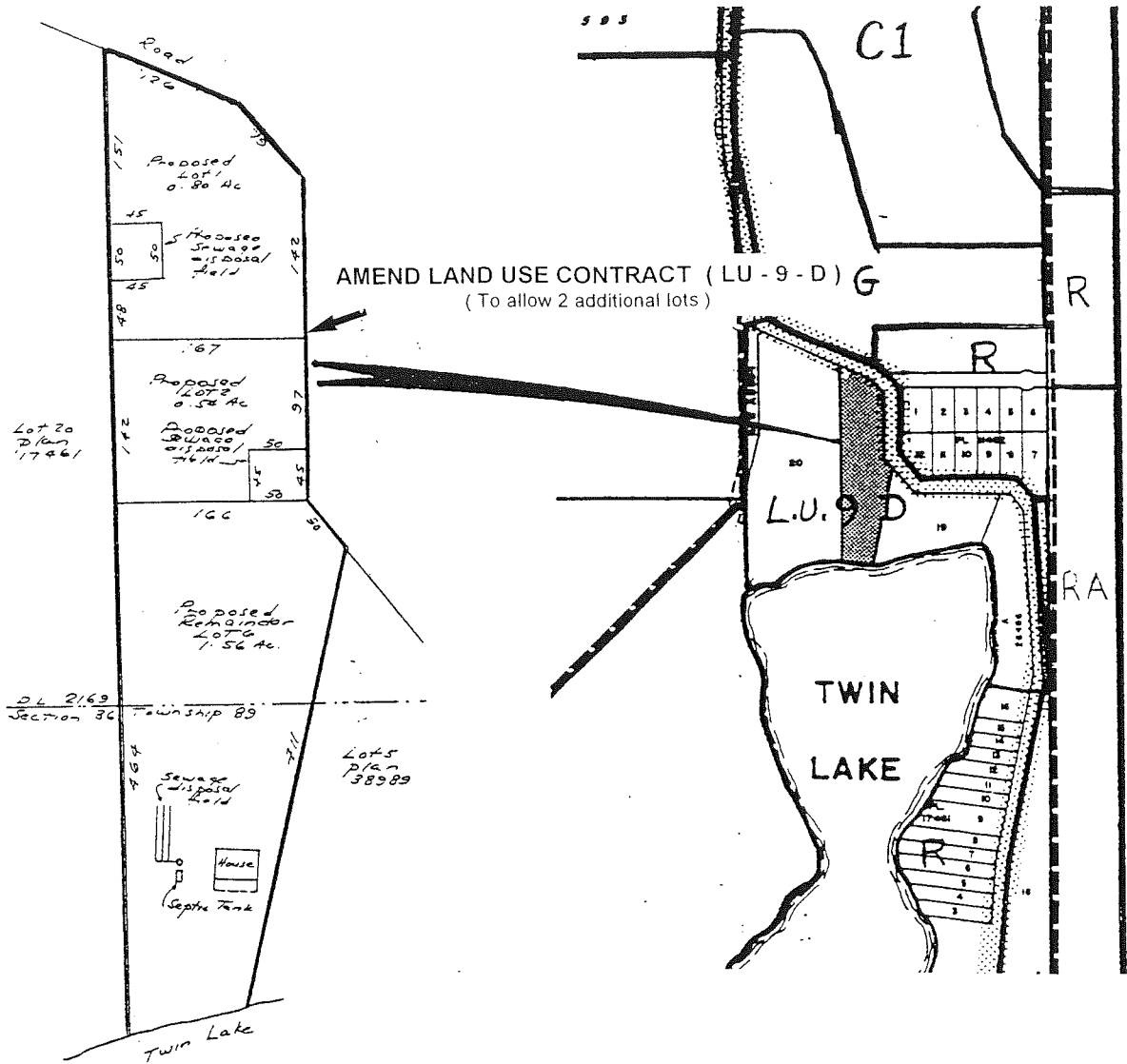
