



ABANDONED CAMPER – RECREATION VEHICLE or CAMPER with Wheels

Disposal Application Form for De-construction at Okanagan Falls Landfill – DRC Sorting Facility

PART 1: This application is for abandoned CAMPER-RV or CAMPER with wheels. Camper-Recreation Vehicles and Campers are now accepted for de-construction to the Okanagan Falls Landfill (LF) – DRC Sorting Facility. RDOS Approval is required before hauling for de-construction. Tipping fees apply. **Do not remove** the abandoned Camper or RV until you have followed ICBC’s decommissioning procedures. Procedures vary depending on where the abandoned unit is located. This Disposal Application form complete after ICBC’s procedures and decommissioning forms are completed and processed.

1 - Fees and Charges Bylaw > Definitions and Fees

CAMPER-RECREATION VEHICLE means a unit designed to be towed behind a motor vehicle or self-propelled, and includes such units commonly known as travel trailers, fifth wheels, camper trailers, pick-up coaches, motorized campers, motorized homes, park model trailers and other similar units, which provide temporary recreational accommodation for the travelling public.

CAMPER means a unit without a motor, with or without wheels such as, but not limited to a slide-in trucker camper, or popup tent trailer.

5 - Abandoned – See Insurance Broker?

For an abandoned CAMPER, or CAMPER-RECREATION VEHICLE **with wheels** (with or without a motor) where the owner is unknown, and you want to remove it from its present location for disposal to Okanagan Falls LF:

- a) **See an Auto Insurance Broker for procedures.** Do not remove the unit from its location until you have ICBC’s decommissioning process completed and processed.
- b) Please note that the decommissioning process takes time.
- c) **When the decommissioning process is completed,** inform the Broker that the unit will be dismantled, parts are not being sold and that you need a copy of the “Owner’s Certificate to state under vehicle status as “Non-Repairable”.
