



# OWNER OWNED, CAMPER-RECREATION VEHICLE or CAMPER

## Disposal Application Form for De-construction at Okanagan Falls Landfill – DRC Sorting Facility

### PART 1:

Camper-Recreation Vehicles and Campers are now accepted to the Okanagan Falls Landfill – DRC Sorting Facility. This form is for owner-owned, not abandoned. **Important: RDOS Approval required before hauling.**

### 1 - Fees and Charges Bylaw > Definition and Fees

CAMPER-RECREATION VEHICLE means a unit designed to be towed behind a motor vehicle or self-propelled, and includes such units commonly known as travel trailers, fifth wheels, camper trailers, pick-up coaches, motorized campers, motorized homes, park model trailers and other similar units, which provide temporary recreational accommodation for the travelling public.

CAMPER means a unit without a motor, with or without wheels such as, but not limited to a slide-in trucker camper, or popup tent trailer.

- Owner to visit your Auto Insurance Broker and ask to complete Form Number APV250. Inform your Broker that the unit will be dismantled, parts are not being sold and that you are wanting to change your Vehicle Status on your Owner's Certificate to "Non-Repairable". **Provide to the RDOS, a copy of the Owner's Certificate that states vehicle status as "Non-Repairable".**

#### 6 - Camper with no wheels and no motor:
