REGIONAL DISTRICT OF OKANAGAN-SIMILKAMEEN BYLAW NO. 1098, 1989

A Bylaw to establish and operate throughout Electoral Area G of the Regional District, a local service, being street lighting systems.

WHEREAS Section 788(1)(h) of the <u>Municipal Act</u>, empowers the Regional District to establish and operate, as a local service, street lighting systems;

AND WHEREAS the boundaries of the service area are the boundaries of Electoral Area G of the Regional District as specified in the March 4, 1966 Letters Patent as amended of the Regional District;

AND WHEREAS pursuant to Section 796 of the <u>Municipal Act</u> the Regional Board has obtained the assent of the electorate;

NOW THEREFORE the Regional Board of the Regional District of Okanagan-Similkameen, in open meeting assembled, ENACTS as follows:

- The Regional Board is hereby empowered and authorized to undertake and carry out, or cause to be undertaken and carried out, establishment of a street lighting system on Highways 3 and 3A, and to do all things necessary in connection therewith, and without limiting the generality of the foregoing, to enter into contracts with such authorities and companies as may be necessary to provide a street lighting system, including cost-sharing with the Ministry of Transportation and Highways.
- 2. The boundaries of the service area are the boundaries of Electoral Area G of the Regional District, as specified in the March 4, 1966 Letters Patent as amended of the Regional District.
- 3. The service area shall comprise Electoral Area G of the Regional District.
- 4. The method of cost recovery for the service shall be as set out in Section 804(1)(a) of the <u>Act</u> with the rates levied on the full assessed value of land and improvements on the basis of Regional Hospital District assessment.
- 5. <u>COST OF SERVICE</u>¹

The maximum annual amount that may be requisitioned under section 4 of this bylaw for the Electoral Area G Street Lighting System is .01/\$1,000 of net taxable value of land and improvements.
