**A Bylaw to amend the Okanagan Valley Zoning Bylaw No. 2800, 2022**

The REGIONAL BOARD of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. This Bylaw may be cited for all purposes as the “Okanagan Valley Zoning Bylaw Amendment Bylaw No. 2800.33, 2024.”
2. The Official Zoning Map, being Schedule ‘2’ of the “Okanagan Valley Zoning Bylaw No. 2800, 2022”, is amended by changing the land use designation on the land described as Lot 133B, Plan KAP2897, District Lot 2450S, SDYD, Except Plan 15135 (5668 Highway 97), and shown shaded yellow on Schedule ‘A’, which forms part of this Bylaw, from part General Industrial (I1) and part General Commercial (C1) to Service Commercial (CS1).

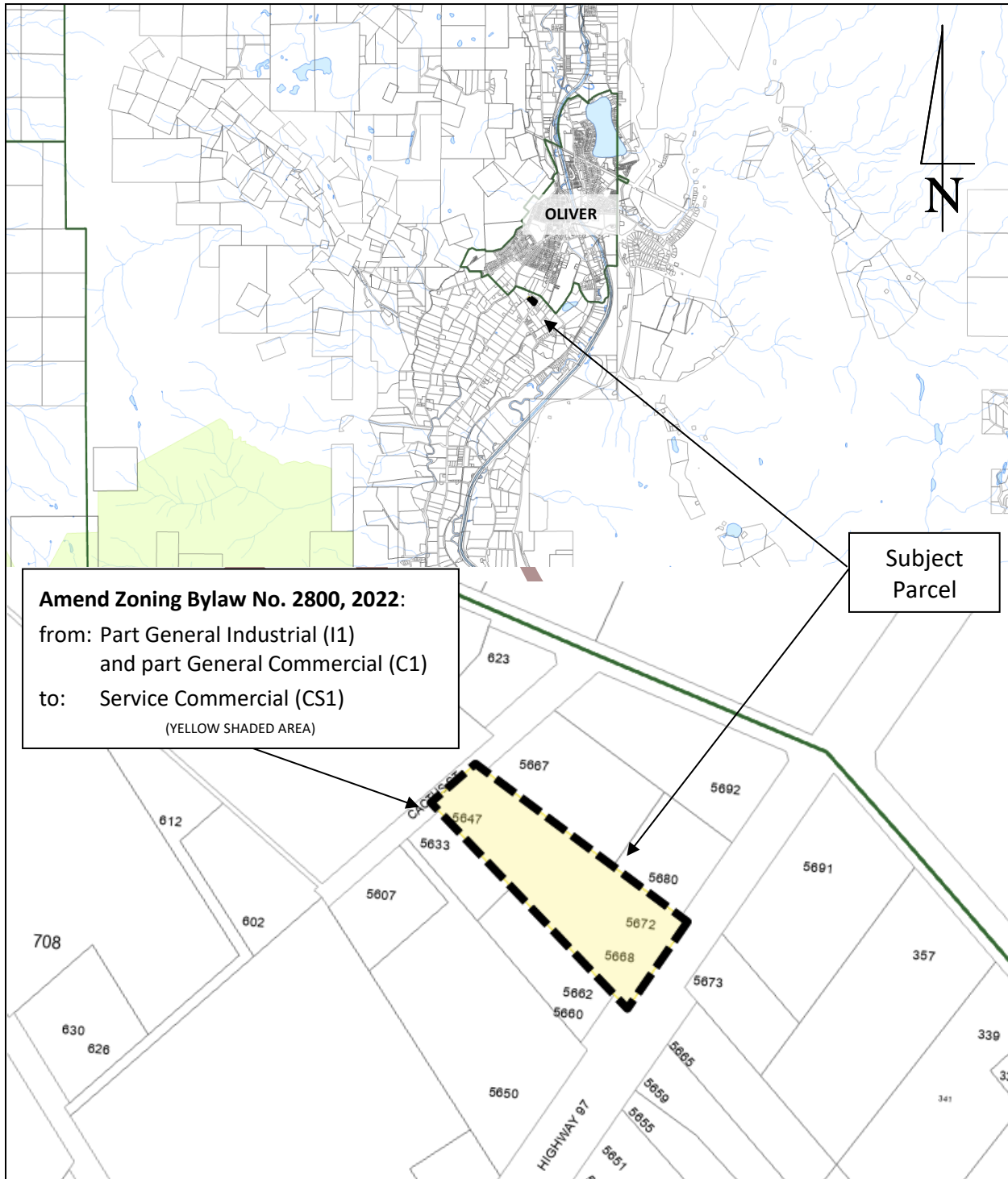
