## TEMPORARY USE

In accordance with Section 21.0 of the Electoral Area "H" Official Community Plan Bylaw No. 2497, 2012, the land specified in Section 5 may be used for a campground use as defined in the Electoral Area "H" Zoning Bylaw, being a parcel of land occupied and maintained for temporary accommodation (maximum 30 days) of the traveling public in tents or recreation vehicles which are licensed for the current year and have been brought to the site by the traveler. May include an office as part of the permitted use but does not

include cabins, hotels, manufactured homes, manufactured home parks, motels or park model trailers.

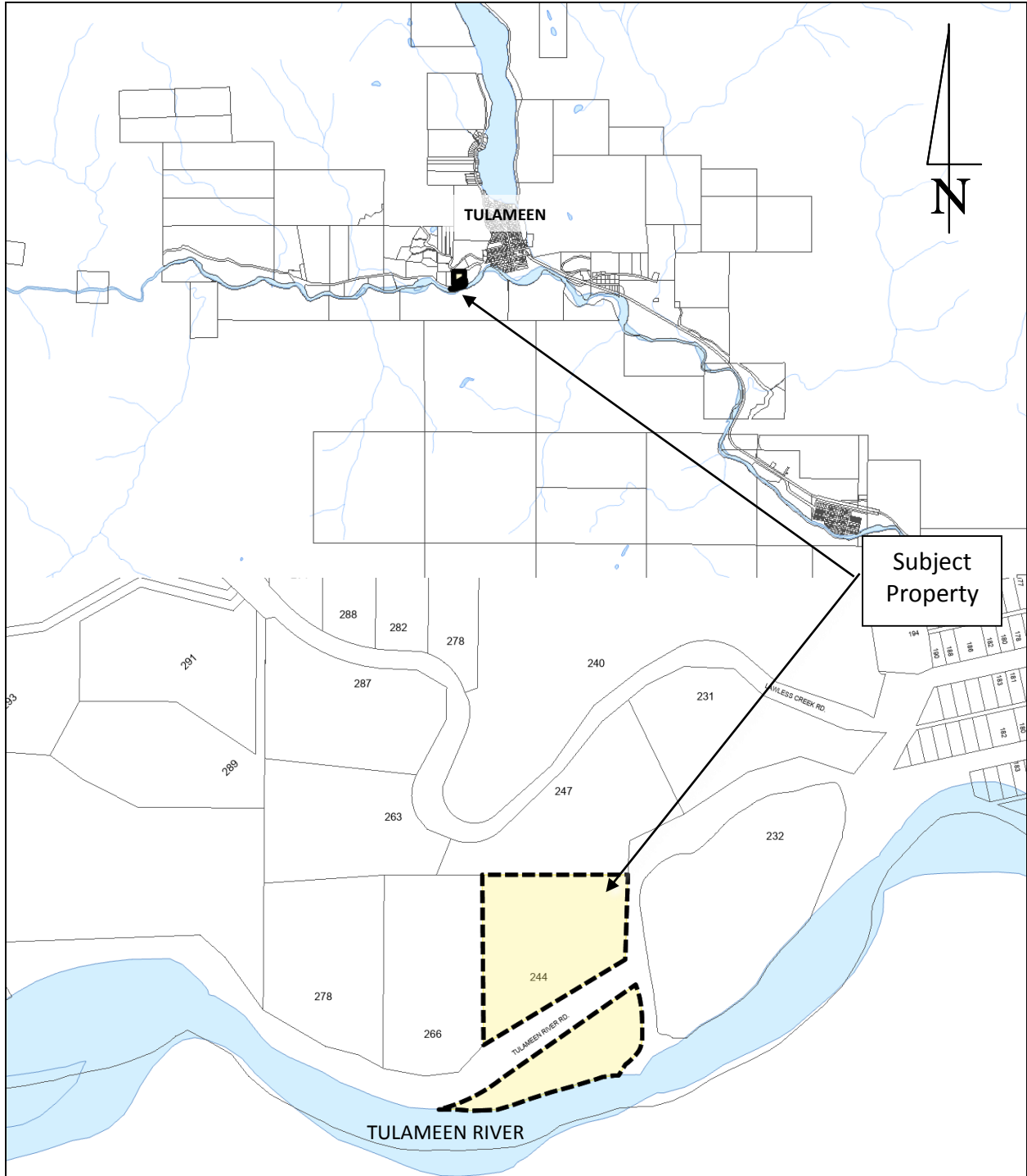

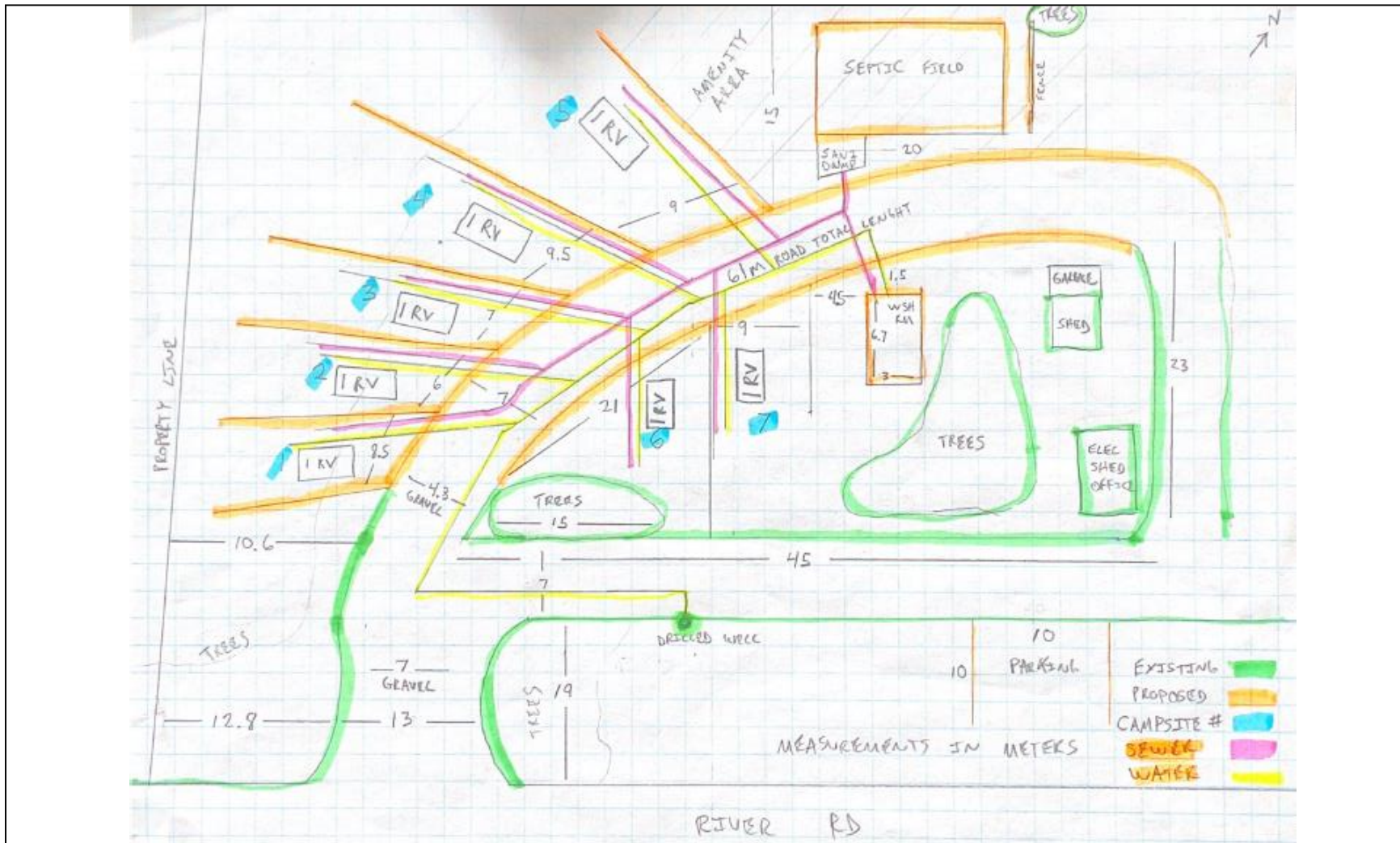
