6. In accordance with Section 23.0 of the Electoral Area "I" Official Community Plan Bylaw No. 2683, 2016, the land specified in Section 5 may be used for the residential use of a recreational vehicle (RV).

"Recreational Vehicle" means a vehicle designed to be towed behind a motor vehicle or self-propelled, and includes such vehicles commonly known as travel trailers, fifth wheels, camper trailers, pick-up coaches, motorized campers, motorized homes, park model

trailers and other similar vehicles, which provide temporary recreational accommodation for the traveling public.

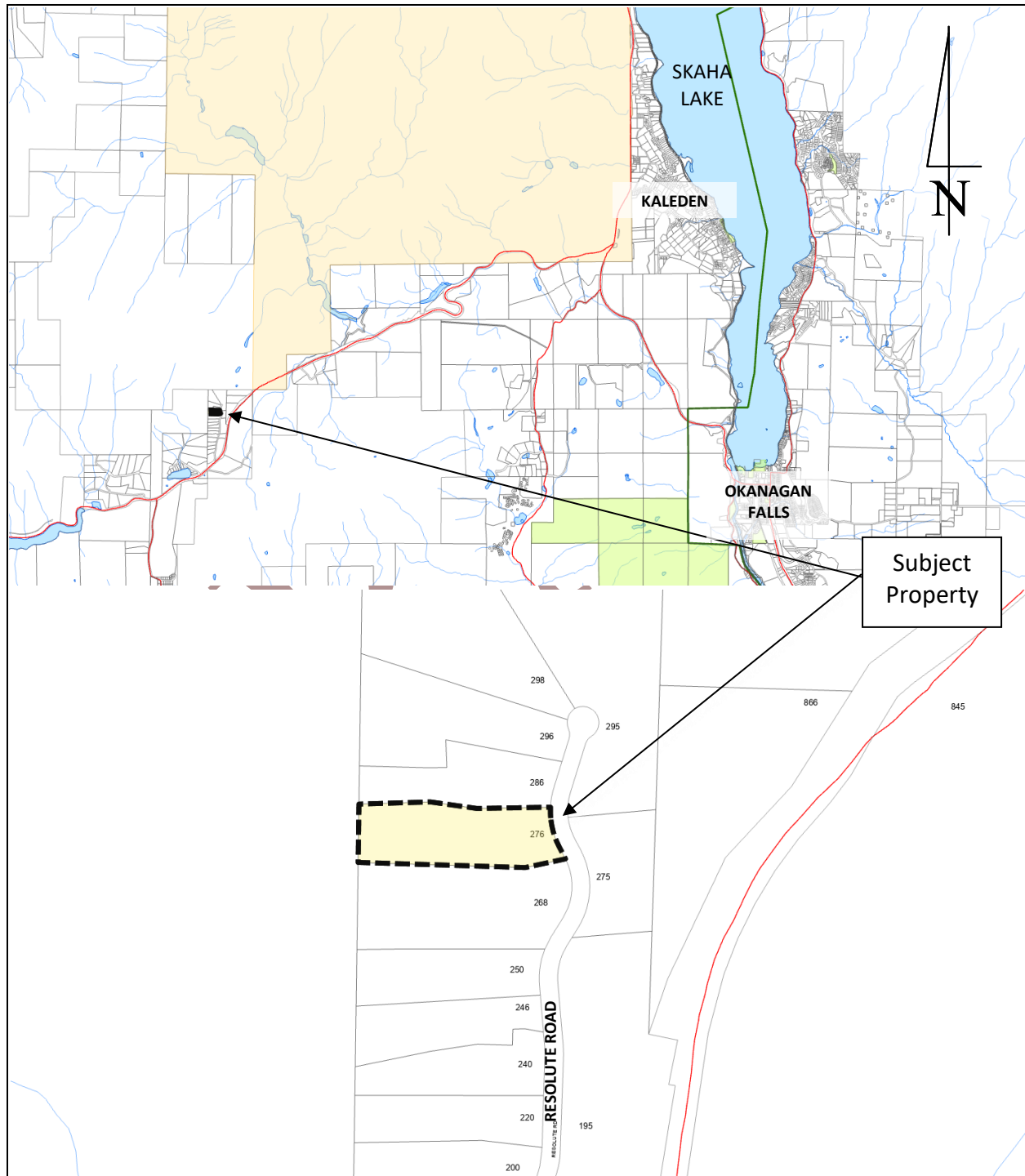

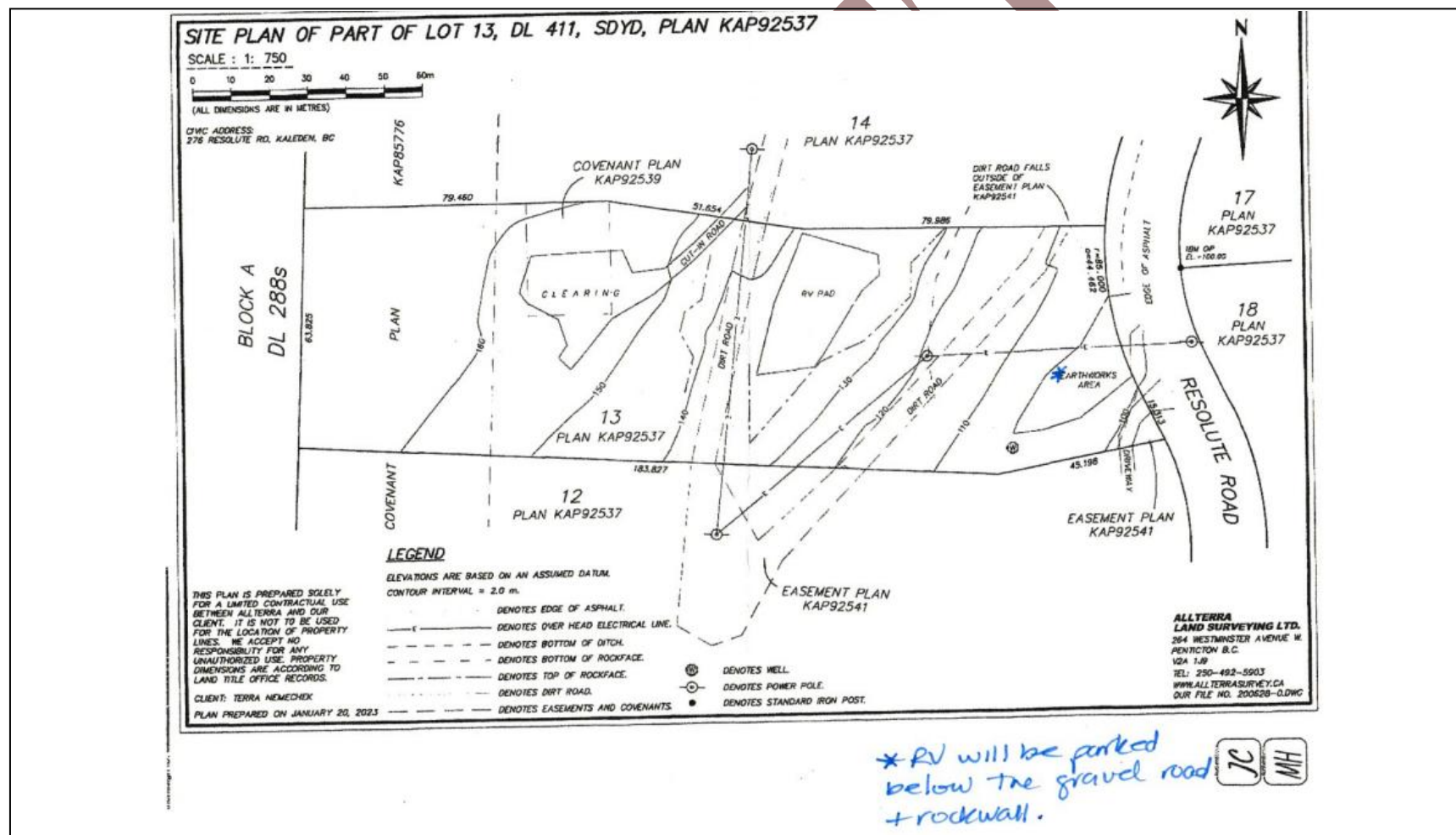
