TEMPORARY USE

6. In accordance with Section 23.0 of the Electoral Area "I" Official Community Plan Bylaw No. 2683, 2016, the land specified in Section 5 may be used for residential occupancy of a "recreational vehicle", as defined in the Okanagan Valley Zoning Bylaw No. 2800, 2022.

CONDITIONS OF TEMPORARY USE

7.	The residential use of a recreational vehicle on the land is subject to the following
	conditions:

- a) The maximum number of recreational vehicles permitted on the property shall be one (1);
- b) The recreational vehicle shall be removed when the permit expires;
- c) The recreational vehicle shall be connected to potable water and electricity; and
- d) The recreational vehicle will not be used for the accommodation of guests or visitors.


